#### Board Approves Trainees as Associate Members

The Appraisal Institute Board of Directors has adopted a proposal to move members who hold an appraiser trainee or equivalent license to associate membership. In addition "aspiring appraisers" also will be in the associate membership category. Aspiring appraisers are described as individuals seeking a trainee license or equivalent from their state but who have not completed the education required for such license. Dues for trainees and aspiring appraisers who are associate members will be \$95 for 2008, which covers dues for both national and chapter combined. These moves come as part of an aggressive membership recruitment program being initiated this year in which the Appraisal Institute aims to add 5.100 new members
