FAREWELL LETTER FROM JOE MAGDZIARZ, MAI, SRA

As I complete my service to the AI, it is appropriate to give thanks to all those I have had the privilege and honor of serving with, First I thank the 2009 National Nominating Committee for having the wisdom to nominate me for vice president based upon my vision of what the AI needed to do to survive. Next I thank the 2008 Board of Directors for having the courage to elect me as the 2009 Vice President. All presidents of AI have a vision or bucket list of what we would like to accomplish.

My vision was to reinvent the AI back into a professional organization/society. I wanted designated members to be the only ones to be able to use the word "member" as a qualification. We needed to reestablish a candidacy program to solve our greatest problem which was a failure to designate new members. As part of this program I had tried to introduce an "educational alternative" to the demo, which is now called the Capstone Program. After four years the program I envisioned was passed. All of these goals were passed in 2011, the year I was President of AI.

In addition during my Presidency we obtained the best lease for the National Office since the merger of AIREA and SREA. We reinstated the national meeting and created a LDAC Alumni meeting as part of this meeting. We held the first ever national BOD meeting in San Juan, Puerto Rico, and probably had the coldest and snowiest February meeting ever in Chicago. We reestablished the University Relations Panel and we redeveloped our business valuation course. I report to you that all my hopes were fulfilled due to the support of our National Staff, the Officers and the Board of Directors, along with excellent support from our Chapters. Mission Accomplished!

With the Capstone program designating individuals will accelerate, as it has this year, and as it likely will over the next several years, regardless of who is President, or who is on the National Board of Directors. The challenge and the charge those after me face is to design and implement programs to convince practicing affiliates and others to move to the candidacy program, and to enhance the stature and reputation of our designations and members.

Completing my tour of duty, I leave the AI with great staff, great officers and a great Board of Directors. I leave my future and that of others in your hands. Again, I cannot express the gratitude I have for what we have accomplished collectively.
