It is an honor for me to serve you as the President of the Great Lakes Chapter for 2018. I'm looking forward to an exciting and busy year. As we begin the New Year, I would like to thank those departing Board members from 2017. Pete Arbor, MAI; Brent Davis, SRA; Robert Davis, SRA; Valerie Lafferty; as well as Past-President Paul Arnold, MAI. Each of these Board members provided their time, energy and talents for three years or more and devoted themselves to serving the Chapter.

The Great Lakes Chapter is already off to a strong start in 2018. We just held our first USPAP class for the year where 90 people were in attendance. There are 23 classes currently planned through October of this year, with plans to add some additional dasses to the list as the year goes on. If you missed the USPAP class in Flint the next offering will be on February 22nd in Lansing. The Board of Directors has continued to make a commitment to offering both continuing education as well as the core educational offerings for individuals who are new to the industry. Last year ended up being a very successful year for education with 22 dasses being offered and 574 students in attendance.

I recently, on January 30th, participated in the Region III conference call. I am happy to say that there are no controversial issues pending at this time. Priority for award will be based on those with the fewest remaining steps towards MAI or SRA designations


